## Securities and Exchange Act B.E. 2535

Section 112. In operating the business of securities brokerage, a securities company shall enter
into a written agreement with the customers who appoint it to act as securities broker. For the purpose of
fairness to the parties, the SEC may specify any particulars which are material to the agreement.
