**Clause 1** The following Notifications shall be repealed:

**Clause 2** An issuer shall prepare the factsheet of securities by identifying the substances of the securities, including key features and risk factors, as specified in the attachment hereto.

**Clause 3** This Notification shall come into force from 1 July 2016.
