Licensing Manual: Application for Approval of Foreign Auditor (In Case of being under supervision of internationally-recognized regulator)

Authority: the Office of the Securities and Exchange Commission (public agency)

Rules, procedures and conditions (if any) for submitting an application and granting an approval: 12.1 The applicant must be a foreign auditor under supervision of internationally-recognized **regulator** as specified in the *Notification of the Office of the Securities and Exchange Commission No. SorChor.*

as specified in the Notification of the Office of the Securities and Exchange Comm 30/2558 Re: Approval of Foreign Auditors dated April 9, 2015;

- 12.2 The applicant must demonstrate to the SEC Office that the applicant is a qualified auditor, by foreign laws or regulations, to audit the financial statements of a company whose securities are traded on the main board of a foreign securities exchange and having auditing experiences on the financial statements of such company. Details of the granting of approval for foreign auditors under supervision of internationally-recognized regulator are specified in Clause 7 of the *Notification of the Office of the Securities and Exchange Commission No. SorChor.* 30/2558 Re: Approval of Foreign Auditors dated April 9, 2015.
- 12.3 The SEC Office begins the period of time for considering the application for approval from the date on which the SEC official has received the required documents in full according to the procedures specified in Clause 13 of the Licensing Manual.

Remarks:

- ** If the application or evidentiary documentation is incorrect or incomplete and cannot be fixed or filled up at the moment, the SEC official who accepts the application and the applicant must sign their names on the record of defect and the list of evidentiary documentation, and a period of time for the applicant to fix or fill up additional information shall be specified. If the applicant fails to do so within such period, the SEC official will return the application and evidentiary documentation to the applicant. In case the application is submitted by an authorized person and the evidentiary documentation is incorrect or incomplete, the authorized person must show a written authorization from the applicant to sign on the record of defect.
- ** If the applicant wishes to submit an application via post and the application or evidentiary documentation is incorrect or incomplete, the SEC Office will send an e-mail notifying list of incorrect or incomplete documents and a period of time for the applicant to fix or fill up additional information.
- ** The SEC Office will not consider the application or begin the processing period until the applicant has corrected the application or submitted additional documents fully according to the record of defect.
